Over the past few days, e-mail and discussion of Facebook and similar social networks are even more highlighted that many of us are still struggling to believe you have received the blessing of participating in this unforgettable moment in human history. "* Henry was so ecstatic for "this unforgettable moment in human history", he declaimed: "*We discovered that members of a large family, a family close-knit.*" Well, boys, what kind of *family* are the "rethinker"! A family deeply *dysfunctional* , how can you understand now anyone who has followed what has happened between the "Perthian" and RA. In fact, the **Feast of Love Oakland** was carefully noting the absence of those in Perth and their supporters, including Anthony Brink, Claus Jensen, Michael Ellner and many others. Evidently did not appreciate the decision not to allow RA Brink, a representative chosen by Eleni Papadopulos-Eleopulos, even a small space to talk. Apparently, there was no space in the program, even after Noreen Martin has withdrawn at the last minute. (...)

We come to the story of the Snout of the ineffable said [Celia Farber](#) :

*"Today I went to a place of healing, high in the hills, where it was built a box that emits the same frequency of pure love. so are translated for me to understand it better, and now I offer: [How the denialist Celia Farber has sued an activist and has lost](#) *the original title: "How Celia Farber to his tried an AIDS activist - and his interview with Richard Jefferys published by Quackdown January 31, 2012. The AIDS denialist Celia Farber has sued Richard Jefferys who had called a liar. In November, the Supreme Court of New York dismissed the action Farber Quackdown interviewed Richard about the case. The interview is fascinating because it describes Richard delight the web of lies, homophobia and madness in the world of AIDS denialists. Richard Jefferys is an AIDS activist for years. He works for the "Treatment Action Group" in New York and has written extensively on science of HIV and immune system. Most of his time is dedicated to educating people about the science of HIV treatment. In 2008, an obscure U.S. group called "the Semmelweis Society" decided to reward the AIDS denialists Celia Farber and Pete Duesberg, and tried to include them in a conference on "whistleblower" (people who reveal hidden tort, NdT) or in Washington attended by several MPs USA. The Farber announced that participation on [page six of the New York on April 25, 2008](#) . After reading the article online, Richard sent a comment using the feedback form the site of conference, in which he wrote that Farber and Duesberg " *are not whistleblowers, are simply liars who for year used fraud to support the thesis long been discredited Duesberg that would be the use of drugs and malnutrition non-HIV to cause AIDS.* " The case was dismissed in November, here's interview with Richard Jefferys Quackdown: Richard, what are the events that led Farber to act against you? In May 2008, Washington had to play off events called "Week of the whistleblower." The site of "Whistleblower Week" is now deceased, but parts of it are archived on [internet archive](#) . The purpose was to emphasize the importance of whistleblowers in disclosing the fraudulent companies and governments. It had been expected a number of events, including a "court" in which the alleged whistleblower would be tried before a jury comprising several MPs. There were several organizations sponsoring the event, including one that was*



"the NO FEAR Coalition" led by Dr. Marsha Coleman-Adebayo, a former president of the DC (District of Columbia) AIDS who had previously spent-and rationally - about AIDS in Africa. But one of the co-sponsors the "Semmelweis Society" (an apparently defended doctors who had lost his job after being the subject of negative peer reviews), decided to invite Farber and fellow AIDS denialist Peter Duesberg, in addition premiandoli with the recognition of the Semmelweis Society Hands Award." I learned of this development from an article in the New York Post. At the time the manager was Richa Johnson of Page Six, who is a longtime friend of Farber. The article was titled "Hands not so bloody" (Not So Bloody Hands). I was impressed by the false announcement that was scheduled for Farber and Duesberg is "rivolgessero to Congress." My concern was not so much that Duesberg and Farber were could persuade someone out of the event participants to believe falsehoods about HIV and AIDS, but rather that they could use their involvement in the same way that Duesberg uses a publication of his journals pseudoscience nonsense, the same way the Farber uses any publication of its promotion of pseudoscience Duesberg of ill-informed media: as a propaganda tool of their long campaign aims to convince non-scientists and in particular people living with HIV-the virus that is harmless or not there. Duesberg acknowledges that HIV exists Farber seems to be faltering. So I sent e-mails to some people, and a list of discussion on federal policies on AIDS of the United States, noting that concern about the involvement of Farber and Duesberg. I sent a brief comment through the feedback form at the site of the conference on Whistleblower, and it was this post-which I stated my opinion that Duesberg and Farber were liars and cheats and also observed that altered and distorted quotations from literature - Farber on who based its lawsuit. I heard about the lawsuit from another article on page six of the [New York Post on May 9, 2009](#).

**Quackdown: On what basis the judge dismissed the lawsuit?** I was very fortunate to be represented *pro bono* lawyer Evall. In the words of the judge "the same complaint of Farber and publications, which has filed to oppose this motion shows that, in the context of issues surrounding HIV and AIDS denialists, and the question of whether HIV causes the AIDS, it is a public figure." In the U.S., the law is that a libel case can be sustained if there is evidence of intent, which is defined as publishing false information about "knowing of their falsity or with recklessness that is false or not." Secondly, the court held that the issue of HIV / AIDS legitimate public concern. This affects the requirements for there to be defamation. [This case] even if the person we are public figure to prove defamation when we are faced with a subject of legitimate public concern must be shown that "who publish defamatory information supposedly acted grossly irresponsible without observing standards on the collection of information dissemination ordinarily followed by those who act responsibly." The judge ruled that my comments were informed, not intentional or grossly negligent, and that therefore the position of Farber was not sustainable, he has accepted the motion for summary proceedings and rejected the demands of Farber towards me. **Quackdown: Can you give us examples of lies told by Farber and Duesberg?** Both have a long history in supporting repeated untruths. Every single itself may seem minor, but these are woven together to form the propaganda that supports the denial of AIDS. Here are examples: - [that Farber's response to an article published in "Harper's Magazine"](#), lists 56 mistakes in Farber's article examples are references to cases of Duesberg, "AIDS in HIV-negative" (which includes his misleading articles that describe people who had neither AIDS nor HIV), the assertion that the antibodies against infections always give immunity except in the case of HIV, the claim that the prevalence of HIV in the U.S. would be stable to 1 million people since 1985, and so on. Farber had recognized errors in the article on "Harper's Magazine", only to walk around him and continue to claim false there were none. For example, in this [comment online](#) 23 April 2006 she admits: "Around the antibody line, I think it would have been preferable if we had corrected the line to say that 'most' of infectious diseases, the antibodies indicate infection or defeat." But this grudging (and even inaccurate) admission is forgotten on 11 July 2006, when the [New York Post's Peter \(yet\)](#) the Farber asserts that the only error in the article on "Harper's Magazine" was about clocks Cuckoo. - The other mentioned in the lawsuit was the alteration of quotations from literature, they had both done. In the case of Farber, an article on "Mothering Magazine" offers the following statement about a study called ACTG 076, which showed that treatment with AZT significantly reduced HIV transmission from mother to child: "Nevertheless, the criticisms that have been made of the design and conclusions of the 076. The same authors of the study, when they reported their findings in the *New England Journal of Medicine* (NEJM) in 1994 recognized that the effectiveness of AZT in reducing maternal transmission of HIV is impossible to quantify [in absolute amounts] because of the very small number of infected infants [studied]. They also noticed that the rate of HIV transmission in the placebo arm was inexplicably high." The term is a reference to the article on the *New England Journal of Medicine*, which also includes two pages from which the quote originated would be: "7. *New England Journal of Medicine* 331, no. 18 (November 3, 1994): 1176-1177." The full text article is [available online](#) for citation states: "it was impossible to identify prognostic factors for HIV transmission (other than treatment) in this arm because of the temporary reduced number of infected infants in the group treated with zidovudine (AZT, NdT)." Then he has altered this quote to falsely claim that, in his words, "... the authors of the study admitted that the effectiveness of AZT in reducing maternal transmission of HIV is impossible to quantify [in absolute amounts]." But the study authors "admit" that. That the summons true, unaffected, he was referring was the attempt to identify other factors-such as other factors count-that they could be associated with the risk of transmission. But, as the authors state, the impact of AZT in reducing the risk of transmission was so great as to preclude the identification of other factors. Additionally, nowhere in the article known, nor it is suggested that "the rate transmission of HIV in the placebo arm was inexplicably high." - Duesberg he uses similar tactics, in one case [by truncating a phrase from an article by Frank Palella](#) for falsely claiming that a study on the effects of HIV treatment had involved only healthy subjects. Duesberg claimed that the article claimed, "we excluded patients from the study, NdT] Patients with a diagnosis of cytomegalovirus retinitis and Mycobacterium avium Complex disease before entering into the study or during the first 30 days of follow-up and patients with Pneumocystis carinii pneumonia at the beginning

active follow-up. " But in the original, this sentence does not end with a period. Instead, it [continues](#) : "... analysis of incidence of these opportunistic infections." Deception is crucial because Duesberg also writes that the study involved Palella "clinically healthy" and "without AIDS" and of course the fact that participants had had AIDS-defining opportunistic infections "before study" reveals the falsity of this statement. - Both Farber as Duesberg also undertake to extract quackery out of context and misreading. A recent example concerns the citation of a sentence of an abstract of an article in *Lancet* out of context to falsely claiming that antiretroviral therapy did not reduce mortality from HIV infection. **Quackdown: case was closed? What will happen now?** Farber's lawyers filed a notice of appeal, then have about nine months to file an appeal. **Quackdown: the AIDS denialism is just a nuisance or dangerous?** is a danger to the health of people with HIV for every person who is affected there is a cascading effect that acts on the people who love and care for them. There is a potential public health impact because people who believe the lies of Holocaust deniers could not do what it takes to prevent HIV transmission. The denialist propaganda film "House of Numbers"-which was funded by the organization of Duesberg "Rethinking AIDS" and is essentially an attempt to make a film version of Duesberg's book "*invented AIDS virus*" - is one of the vehicles most recent success for the promotion of Holocaust denial. If you visit the Facebook page of the film, there are examples of individuals with HIV who claim to have abandoned the medical care because of the lies promoted by this film and two HIV-positive women who were part of the board of Rethinking AIDS, who decided to finance the film and who were interviewed in the film Marie-Christine Bannon-Major and Kim have both died of AIDS. The daughter of three years [at the time, NdT] also of higher death of this disease several years later. **Quackdown: Most people do not know how crazy AIDS denialists. Fischer has decided to promote AIDS denialism, and Duesberg has promoted the discredited theory and no evidence that AIDS is caused by the behavior of gay men that has been promoting for three decades. If the idea of a link between Baker Duesberg and seemed unlikely, here they are together, with friends Farber and Duesberg's board of Rethinking AIDS and interviewed in "House of Numbers" Neville Hodgkinson and Christie at the premiere of "House of Numbers" in Nashville: Fiala is far left, Baker has a hand on his shoulder. The Farber is behind immediately next to Baker, who knelt before Duesberg and Hodgkinson is on the far right. **Quackdown: do you think the lawsuit filed by Farber is an attempt to silence legitimate criticism on AIDS denialism?** Yes, I think it was an attempt at intimidation. On Wikipedia there is an entry for a type of legal action called "strategic lawsuit against public participation" ([strategic lawsuit Against Public Participation, SLAPP](#) ). And this lawsuit seems to fully get into it. **Quackdown: In 2011 the British Chiropractic Association against science writer Simon Singh. Before Matthias Rath has tried unsuccessfully to take action against Ben Goldacre but his lawsuit against the *British Medical Journal* hath been concluded with a conviction for the BMJ to pay 100.000 pounds. More recently, the Texas Bioethics Clinic has threatened a sixteen year old blogger to have shown their quackery. In South Africa, a company called Bioethics Technologies has threatened to sue for defamation several of his critics. Are the courts to settle disagreements in medicine? Not when the disagreements are entitled from the evidence, no. But the courts have a role to play as a potentially important tool to combat those who illegally promote harmful quackery. **Quackdown: On the other hand, complaints raised against an alleged unethical conduct of Duesberg at his university, and the TAC has acted in judgment for the activities of Matthias Rath. The TAC regularly takes up complaints against advertisements of quacks. There is no equivalence between such actions and that proposed by Farber? No. The University of Duesberg has a code of conduct that prohibits the violation of the "canons of intellectual honesty" and that's what he is doing for decades on HIV. Rath was in the illegal promotion of its products, as do other medical quacks. Farber's work would not be subjected to the type of criticism that led her to sue me if it were not so disproportionately false and full of errors and misrepresentations. **Quackdown finally, Richard?** I was very fortunate to have the support of the organization I work for, "the [Treatment Action Group](#) ", and excellent defense lawyer Joe Evall, a longtime supporter of TAG. Others might not be in a position so lucky, so I consider the possibility of using the legal system to intimidate those who criticize them. [This is a translation from the original article. ## THE HISTORY OF Karri Stokely

While the next story I will tell ( but it will take some 'time, because I have to postpone it until after CROI ) in Italy has not heard anything, Karri Stokely's story is not new, at least to readers of this forum. I take an intervention Mancer ( [Karri Stokely, latest victim of dissent / denial](#) ), to describe it very briefly and then add some details and some further consideration to make it more understandable.

( <http://www.karristokely.com/> ) ( <http://www.facebook.com/kstokely2> ) What she says on her website, ( <http://www.livingwithouthivdrugs.com> , a site from a few days has disappeared from the internet, but still accessible from google cache [ [Note Dora](#) : *Now you can read here:* <http://www.livingwithouthivdrugs.com/karri.htm> ): from what I understand was a nurse. He was diagnosed with HIV in 1996, after the birth of their second son (her husband and children, fortunately results S-). CD4 and Viral load 58,000 = 29, ie AIDS. 3. Immediately begins therapy with AZT, 3TC, Crixivan, and Bactrim, then settles on AZT, 3TC and Sustiva through April 2007 (11 years) 4. In April 2007 her husband Joe (according to her, it seems that not scopassero more), hacking on the internet, picked up the film denier "The Other Side of AIDS" by Robin Scoville (S-, husband of Christine Maggiore S + known dissident and denialist , with S + small daughter who has denied HAART, both died - not her husband) and shows it to Karri 5. This has been going up in April 2011 (4 years, without HAART). Participate actively in the promotion of the film "House of Numbers" ( <http://www.houseofnumbers.com/site> ), another film dissident / denialist 8. Then collapses, falls ill, is hospitalized but his immune system is now on the ropes and does not respond to treatment. The end is known. 9. Curious, Mancer said. Let us know if Todd had perhaps reasons dating back to childhood squabbles to resent Karri - who knows? maybe she was stealing candy when they were kids, or had some good reason for resentment and anger towards this cousin.

We start from the end: from the post published April 12, 2011 by "guyn2gear", two weeks before the death of Karri . [Goodbye and good riddance, Karri Stokely, you bitch AIDS denialist](#) A title that seems completely devoid of piety, in front of a person who is dying: "Farewell, a liberation, Karri Stokely, bitch AIDS denialist" . And the concluding words of the post seems far more merciless "Karri Stokely, you are getting what you deserve - Karri Stokely, you get what you deserve." Then on April 26, the day of death of Karri, Todd noted that updated the post and wrote a new one, "which aims to soften a bit 'of anger vented" in previous message: [AIDS denialism kills, period.](#) - "THE KILLING OF AIDS denialism. POINT. " This is a crazy cousin to be so furious against a poor woman who - in his last months of life - has been devastated by unspeakable pain caused by a terrible abscess in the rectum, that caused bleeding continued and forced to spend literally months in a hyperbaric chamber (she tells them, in great detail in his blog: [Thoughts, Musings, Ramblings and](#) )? Or is a good person, as has repeatedly said, surrounded by friends is HIV positive facing with courage antiretroviral therapies, and is shocked by the evil done by that Karri, manipulated and brainwashed by some deniers of Rethinking AIDS, lent itself to spread in every way possible their bestiality and encouraged more patients to abandon the HAART and causing an indeterminable number of people infected, because they have had unprotected sex in the belief that HIV is not a danger, but a "business of Big Pharma?" Let's put aside the pity for a woman dead and Karri see what he did in his last year of life. *And PLEASE, do not you listen to these charlatans when they try to tell you that "all drugs have side effects ". Yes, it is true. And sometimes the side effects could also be justified if you have a REAL infection, which must be addressed.*

*This is not the case of" "HIV."*

*Please, please, do your duty. Do what you have to with diligence. My mission is to try not to ever have to hear another story about people like me. On how many of you people. If we survive, there is a reason. It is to make a change. It is to help save lives. (...) I pray that others continue to challenge this false paradigm, because they do research on their own and are strong enough to make the right decisions about their health and their personal well-being.*

*December 1, 2010: Good day world of fraud AID \$ \$ \$ \$ \$ \$!*

*I sit here, 'this morning to reflect on the dimensions of corruption and fraud that was enforced on the world in the last 25 + years for all that concerns' "HIV". This short paper, today, is dedicated to all those who lost their lives because of the wicked and perverse industry AID \$ \$ and have been poisoned to death by their drugs "lifesaver."*

*So many, so many lives. Devastate. Massacred. All in the name of money. Power. Prestige.*

*Today my heart is sad to think how many of those lives were cut short prematurely, all in the name of Gallo, Fauci of, Moore and others like them.*

*I do not know how it can happen that a person may grow into as them. Heartless men. Cruel.*

*Fortunately, thanks to the Internet and the great exchange of information possible today, people begin to be aware of this fraud. LIVES BEGIN TO BE SAVED. (...)*

*So today, in honor of the most disgusting day of the year in favor of the Hindu industry AID \$ \$, if you happen to pass by the side of a point-sampling, where the software is tested, I ask each of you to speak clearly, to challenge them, to tell them that they are responsible.*

*Unfortunately, most people who take part in these events has no idea of the true science that surrounds this project.*

*TO HELP EDUCATE.*

*MAKE A DIFFERENCE.*

*December 2, 2010: ... And THIS is why I do what I do!*

*(...) You are all heroes in this great battle for the truth. For ALL TYPES of truth! Please, continue to be courageous, to share and to do what each of you is called to do. (...)*

*January 10, 2011: Recipe for Medical AID \$*

*Duesberg has just hit the target when he called this disease \$ AID Recipe for Medica. Do not think for a moment that the AID \$ industry does not know what they're doing with this well-orchestrated campaign of poisoning by drugs. (...)*

I will stop here. I think that the quotes used are sufficient to understand the extent to which Karri suffered brainwashed by the deniers and their theories. Victim was, of course, because in its weakness met people who knew how to speak to her fear of the disease, his pain, and knew how to ring in her the ropes that are tied to the contempt for Western science, the terror of the side effects of drugs, the idea that everything is a conspiracy by Big Pharma to earn money on the skin of naive patients, even at the cost of inventing a disease "nonexistent" and poison them with their chemical poisons. Deniers play about paranoia - so prevalent in our world - that everything is a huge conspiracy, that all (or most of) the scientists are bad people, the pay of industries run by ruthless criminals. That all tramino against us to hurt us. They play a distrust of chemicals and drugs that we derive

from it and the passion for everything that is "organic", "natural" as if this were automatically good, clean, honest. They play on the idea that all information is manipulated and that they alone are the heroes of Truth, that challenge the scientific establishment at the cost of their careers and sometimes their very lives for the truth to prevail: the ' HIV exists only in the fears instilled in patients and would rather medications taken against it leading to death. manipulation and plagiarism by the deniers of Karri Stokely, as well as Christine Maggiore, Kim Bannon, Emery Taylor, exploited and pushed to act as spokespersons for their homicidal theories, not ended with the death of Karri, but continued after. In fact, everyone rushed to claim that the death of this victim was not because of their abandonment of a typical disease and antiretroviral therapy for AIDS-related pneumocystis carinii pneumonia which, but rather to the fact that for 11 years had received antiretroviral drugs, and that they "had poisoned."
